### Overdose prevention and response

#### **BC Coroners Service Update**

The BC Coroners Service has changed how they are reporting the illicit drug toxicity numbers. They are now providing them on a dashboard located here.

The BCCDC has a number of public dashboards, please go to <u>Unregulated Drug Poisoning Emergency Dashboard (bccdc.ca)</u>.

#### **BC Summary**:

- The rate of illicit drug toxicity deaths in BC is 46.9 deaths per 100,000 individuals in January 2023
- In January 2023, there were 211 suspected illicit drug toxicity deaths.
- The number of illicit drug toxicity deaths in January 2023 equates to about 6.8 deaths per day.
- By Health Authority (HA), in January 2023, the highest rates were in VCH (64 deaths per 100,000 individuals) and Island Health (52 deaths per 100,000 individuals); the highest number of illicit drug toxicity deaths were in Fraser and Vancouver Coastal Health Authorities (68 and 60 deaths, respectively), making up 51% of all such deaths in January 2023

#### **Northern Health Summary**

• In 2023, Northern Health has the third highest rate of illicit drug toxicity deaths in the province with a rate of 50.9 deaths per 100,000 individuals (N=13).

- In January 2023, there was approximately an 29% decrease in the rate of illicit drug toxicity deaths compared to the previous month; 4.2 deaths per 100,000 individuals (N=13) in January 2023 compared to ~5.9 deaths per 100,000 individuals (N=18) in December 2022
- The Northwest region has seen 4 illicit drug toxicity deaths in 2023 for a rate of 61.4 deaths per 100,000 individuals. This is the fourth highest rate in BC.
  - January 2023 there was 4 illicit drug toxicity death
  - In 2022
    - Terrace Local Health Area (LHA) 110.5 illicit drug toxicity deaths per 100,000 individuals – second highest in BC
    - Kitimat LHA 72.8 illicit drug toxicity deaths per 100,000 individuals ninth highest in BC
- The Northern Interior has seen 9 illicit drug toxicity deaths in 2023 for a rate of 69.7 deaths per 100,000 individuals. This is the second highest rate in BC.
  - January 2023 there were 9 illicit drug toxicity deaths
  - In 2022
    - Prince George LHA 79.0 illicit drug toxicity deaths per 100,000 individuals
      fifth highest in BC
- The Northeast region has seen 0 illicit drug toxicity deaths in 2023. This was one of two HSDA not to experience an overdose death in BC for January 2023.
  - December 2022 there were 2 illicit drug toxicity deaths
  - In 2022, no Northeast LHA's were among the top 25 for Illicit Drug Toxicity Death Rates

The system sends text alerts with timely information and up-to-date resources to people who use drugs, those who support them, and community members. #### COVID-19
